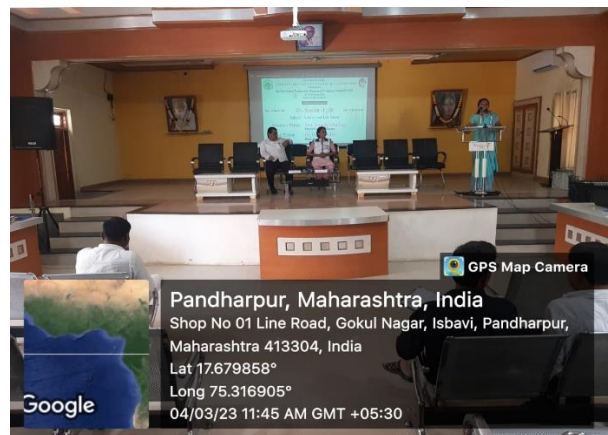

Session-I, Values and Life Skills (11:30 AM to 12:30 PM)

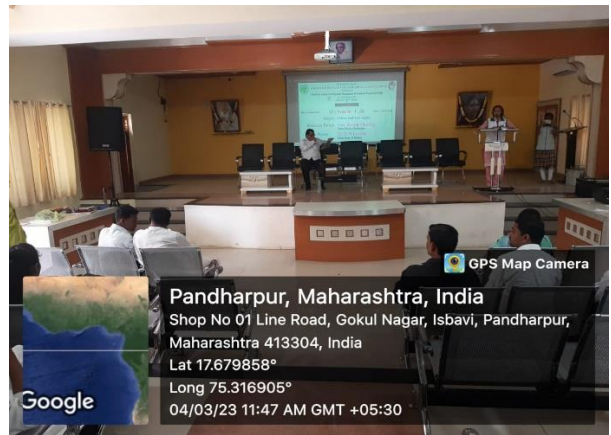

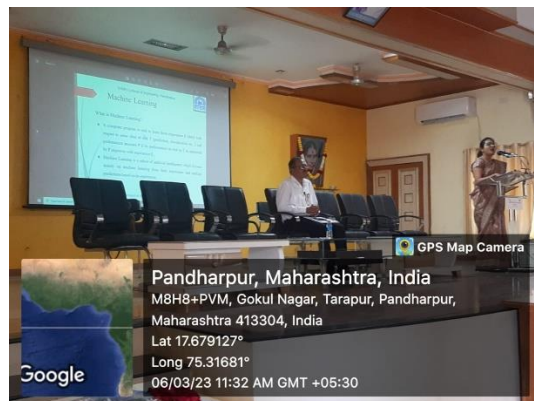
