It was proposed by the COE that HODs may provide the assignment questions to the U.G.- II, III and P.G.-II year students on the what's app groups formed for respective subjects. And then to collect the responses from the students on the departmental email id of respective department.
- Then it was also decided to conduct online test of students for CIE. So it was decided to provide the link to the students through what's app groups. And then collect the responses.
- It was suggested by few faculty members that End Semester examination of this session can be conducted by developing the question papers in two parts i.e. one containing few Multiple-Choice Questions as part of End Semester Exams and another part containing some questions as part of Internal assessment as it may not be possible to conduct online internal

assessment test/exams for all students TESTMOZ should be used for conducting the examinations.

- ▶ It was also suggested that question bank containing of hundreds of questions can be developed by faculty members and uploaded on college website to facilitate students to prepare for their exams.
- ▶ It was also suggested that End Semester exams for UG & PG students should be conducted after getting the guidelines from UGC and PAHSUS.
